



NECESSARY INFORMATION FOR CAR SHIPMENT

Please forward your proforma invoice (draft invoice) containing the following information to us:

1. Seller (Shipper)

- Name

- Telephone
- Organisational number / Personal number – 10 digits.

2. Buyer (Consignee) in Ethiopia

- Name
- Address
- Telephone
- TIN-number (Taxpayer Identification Number - 10 digits)

3. The final destination of the car (DJIBOUTI or GELAN DRY PORT in Ethiopia) including PERMIT NO for DRY PORT shipments

4. Car Details

- Brand
- Model
- Registration number / chassi number

5. The Car's Value (selling price)

Please note that the sea freight for passenger cars and minivans is prepaid for shipments to Djibouti. To offer a price we need to know the car's **brand, model, and registration number.**

IMPORTANT INFORMATION FOR CAR SHIPMENT

After you have made a booking and delivered the instructions regarding seller and buyer you will receive a **confirmation** and a **marking label** to put up in the front window of the vehicle.

The vehicles need to be delivered to **Wallhamn AB (RoRo Port) at Tjörn**.

Wallhamn is located on the east side of Tjörn, near Kållekär and about a 15 minute drive from the high way E6.

Make sure the license plates are removed from the vehicle after delivery to the port, or before a car transporter picks up the vehicle at your location.

IMPORTANT: It is **NOT** allowed to send any additional cargo **OR** additional tires in the car!

When the vessel has departed you will receive the following documents:

1. Invoice from ESL – Freightman AB, to be paid immediately.
2. Customs documents (if you are the owner of the car upon export).
3. Copy of Bill of Lading (BL) (if you are the owner of the car upon export).

To deregister your car as exported from Sweden, send the following documents to **Transportstyrelsen** (Address: 701 81 Örebro):

1. **Yellow part (part 2)** of the registration certificate – check the “export-box” in part two of the registration certificate and put your signature at the bottom. For more information:

2. **Customs document** (serves as proof of export)
3. **Copy of Bill of Lading** (serves as proof of export)
4. **The license plates of the car**

Do not register a change of ownership on the car close to the planned export date without informing us duly in advance. The customs declaration will be created based on the current owner of the car which will be checked against the vehicle registration database. You can NOT export any leased cars.

Original Bill of Lading will be released once payment for our invoice has been received.

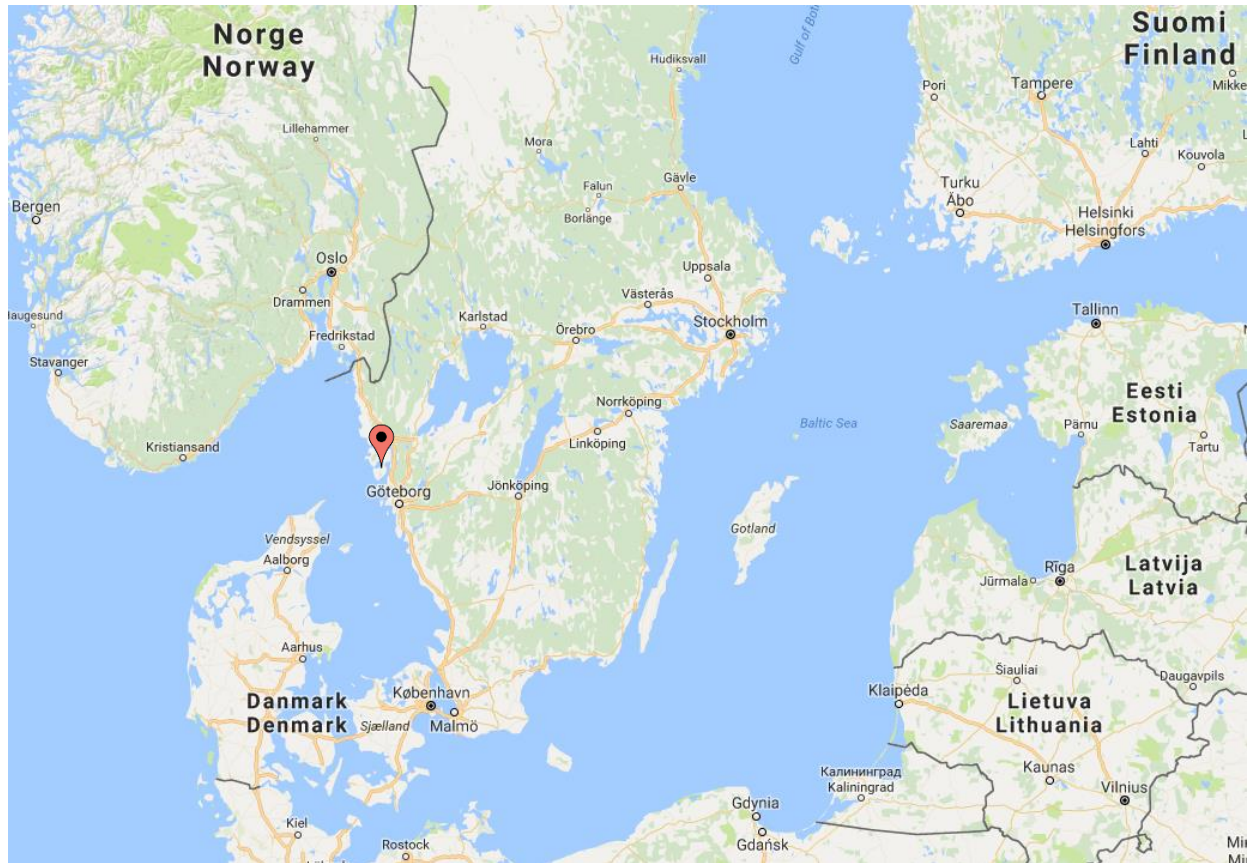

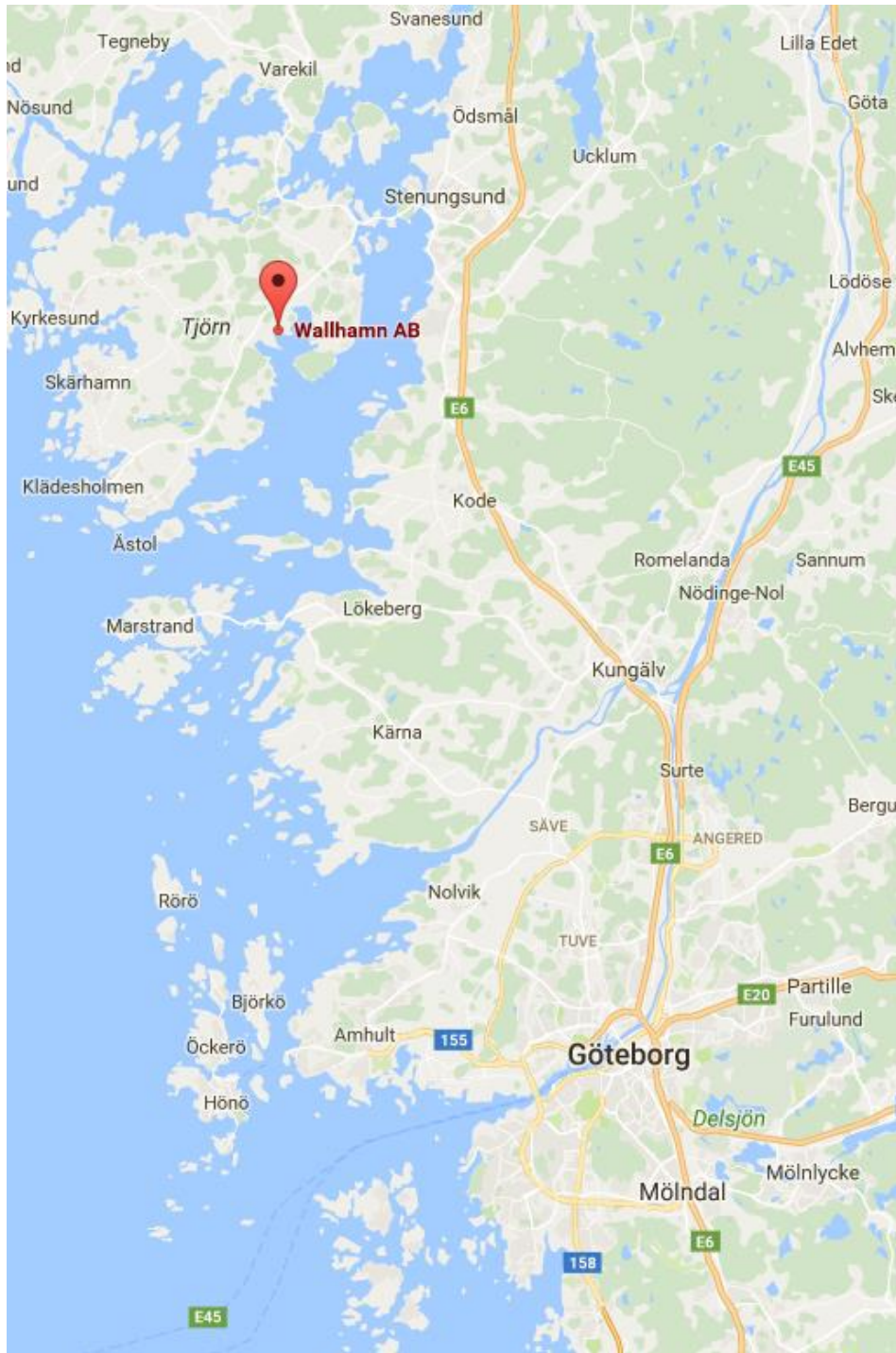
