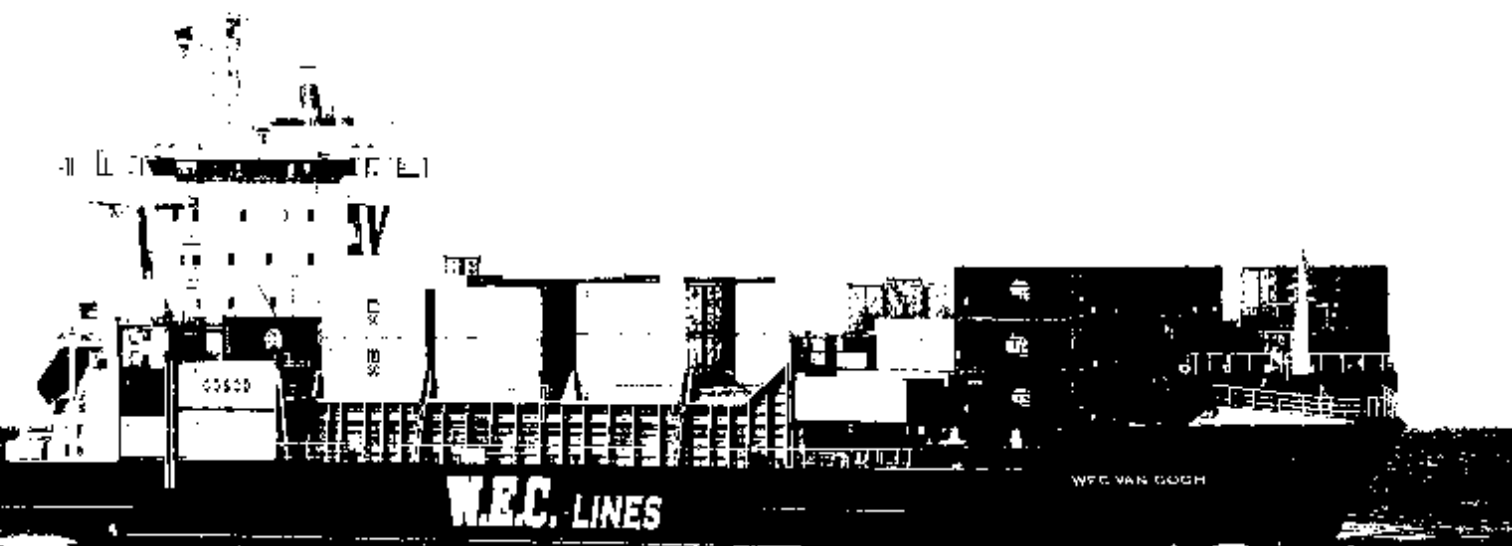

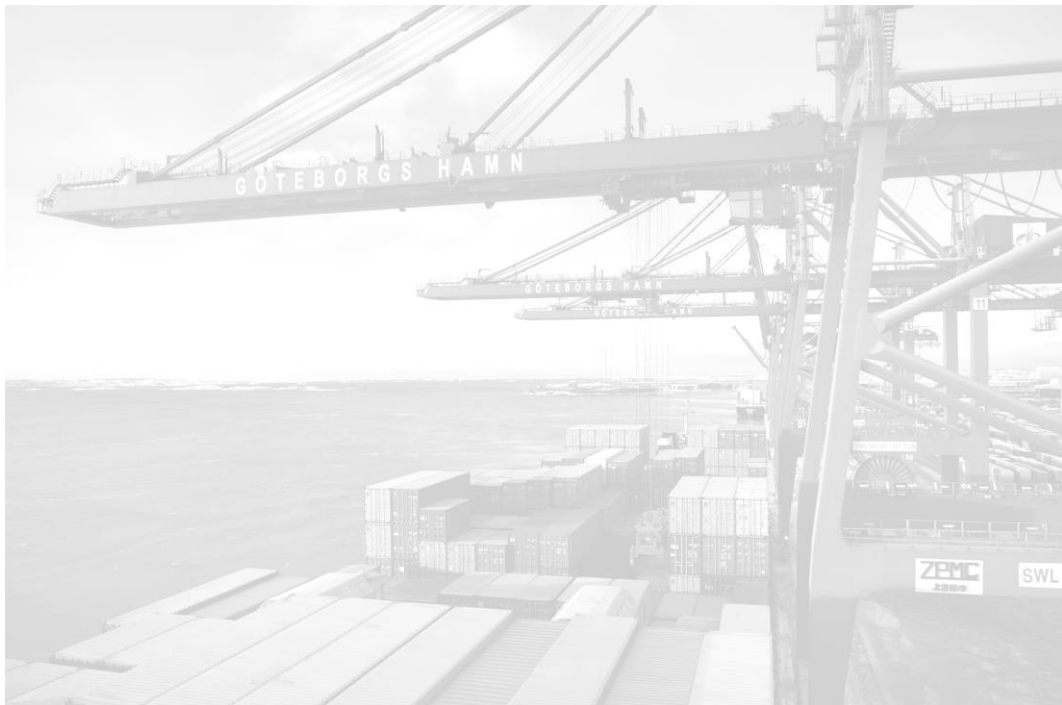


INTRODUCTION

This document is to be used as a tool for your convenience and offers the possibility for you to pre estimate port terminal storage charges that may occur.

Please be advised that stated port storage is no WEC Line charge, nor fee. The costs initiated, and charged by said Port of Discharge / Loading.

The storage service charges stated are valid until further.
We take no responsibility for short term changes that are out of our control.



PORT STORAGE

Definition:

Service charge from respective port for holding and storing the unit within secure and fenced terminal area until container picked-up or shipped. Rates are counting for normal Dry-van and High-Cube Containers. Obnoxious cargo, reefer-units etc may be subject additional charges.



Port of Helsingborg

Storage of Loaded IMPORT units entitled to 7 calendar days including the day of arrival. There after:

20´	-	219 SEK (Per started day)
40´	-	438 SEK (Per started day)

Storage of Loaded EXPORT units entitled to 7 calendar days including the day of arrival. There after:

20´	-	72 SEK (Per started day)
40´	-	144 SEK (Per started day)

Containers that need electrical connection will be charged a connection fee of SEK 285 followed by a daily electrical fee and temp-check of SEK 342 / day.

Units containing dangerous goods according to IMDG / ADR / RID code will be stored on a secluded area at an additional handling fee of SEK 320.

Copenhagen Malmö Port, CMP

Storage of Loaded IMPORT/EXPORT units entitled to 10 free calendar days including the day of arrival. There after:

20´	-	50 SEK (Day >10)
40´	-	100 SEK (Day >10)

Port of Södertälje

Storage of Loaded IMPORT units is entitled to the day of arrival plus 3 additional free days. There after charged per day with:

20´	-	100 SEK (Day 5 - 6)
20´	-	200 SEK (Day >7)
40´	-	200 SEK (Day 5 - 6)
40´	-	400 SEK (Day >7)

Storage of Loaded EXPORT units entitled to the day of arrival plus 6 additional free days. There after:

20´	-	200 SEK (Per started day)
40´	-	400 SEK (Per started day)

Containers that need electrical connection will be charged a connection fee of SEK 432 followed by a daily electrical fee and temp-check of SEK 275 / day. Containers that need to be reported in acc with NFA directives charged SEK 336/unit. Transport to Designated Point of Entry, DPE area SEK 374/unit.

APM Terminals Gothenburg

Storage of Loaded IMPORT units entitled to 3 free working days. The free period includes the day of vessel discharge and the following three(3) working days.

20´	-	107 SEK (Day 1-3)
20´	-	278 SEK (Day 4-7)
20´	-	465 SEK (Day >8)
40´	-	214 SEK (Day 1-3)
40´	-	556 SEK (Day 4-7)
40´	-	938 SEK (Day >8)

Storage of Loaded EXPORT/TRANSHIPMENT units has 5 free storage working days. The free period for export includes the day of vessel loading and the preceding five (5) working days.

20´	-	278 SEK (Day 4-7)
20´	-	465 SEK (Day >8)
40´	-	214 SEK (Day 1-3)
40´	-	556 SEK (Day 4-7)

Storage Surcharges Gothenburg (Per unit and calendar day)

- Electric Supply Units	SEK 469 / Day
- IMO Cargo Units	SEK 275 / Day
- OOG Units	SEK 176 / Day

Storage surcharges on units containing **dangerous goods** and/or **OOG** units benefit from free storage on the days of vessel discharge or day of vessel loading, and will not be debited for the first SAT and SUN.

Temperature controlled reefer units are exempted from free storage and debited from date of arrival until date of departure.

The surcharge for Electric supply/temperature controlled units include handling, monitoring and power supply.

Port of Stockholm, CTN Norvik

Storage of loaded units arriving/departing from the port is entitled to 5 free calendar days. There after:

20´	-	0 SEK (Day 1-5)
20´	-	70 SEK (Day 6-7)
20´	-	264 SEK (Day > 8)
40´	-	0 SEK (Day 1-5)
40´	-	140 SEK (Day 6-7)
40´	-	528 SEK (Day > 8)

Units with IMO-classed cargo are not entitled to any fee storage and is charged from day 1-8 by SEK 72 TEU/Day and >8 Day with SEK 312 TEU/Day

Port of Norrköping

Storage of Loaded IMPORT units arrived with **VESSEL** is free of charge for 4 working days. (Arrival day + 3). There after:

		<u>Day 5 and 6</u>	<u>Day 7 and over</u>
20´	-	81 SEK (Per started day)	198 SEK (Per started day)
40´	-	160 SEK (Per started day)	395 SEK (Per started day)

Storage of Loaded IMPORT units arrived with **RAIL** is free of charge for 2 working days (Arrival day +1). There after:

		<u>Day 3-4</u>	<u>Day 5 and over</u>
20´	-	81 SEK (Per started day)	198 SEK (Per started day)
40´	-	160 SEK (Per started day)	395 SEK (Per started day)

Storage of Loaded EXPORT units departing with **VESSEL** is free of charge for 4 working days (Arrival day + 3). There after:

		<u>Day 5 and 6</u>	<u>Day 7 and over</u>
20´	-	81 SEK (Per started day)	236 SEK (Per started day)
40´	-	160 SEK (Per started day)	469 SEK (Per started day)

Storage of Loaded EXPORT units departing with **RAIL** is free of charge for 2 working days (Arrival day +1). There after:

		<u>Day 3-4</u>	<u>Day 5 and over</u>
20´	-	81 SEK (Per started day)	236 SEK (Per started day)
40´	-	160 SEK (Per started day)	469 SEK (Per started day)

Containers that need electrical connection will be charged a connection fee of SEK 437 followed by a daily electrical fee of SEK 163 / day.

Daily control is charge by SEK 218 / Unit on weekdays and SEK 708 / Unit on weekends and holiday.

Units containing dangerous goods according to IMDG / ADR / RID code will be stored on a secluded area at an additional fee of SEK 296 / Unit

Gävle Container Terminal, GCT


Storage of Loaded units entitled to 5 free calendar days including the day of arrival and departure. There after:

20´ - 102 SEK (Per started day)
 40´ - 204 SEK (Per started day)

Containers that need electrical connection will be charged a connection fee of SEK 449 followed by a daily electrical fee and temp-check of SEK 225 / day. IMDG/Reefer surcharge (per unit) SEK 357
